



Minimum Advertised Price (MAP) Policy

Password:JDM strongly believes that its line of parts and accessories is of the highest quality and a direct result of its investment in engineering, design and manufacturing technology and personnel. Therefore, in order to maintain the integrity of the Password:JDM product line and protect our network of dealer and wholesale distributors it has implemented and will enforce a **MINIMUM ADVERTISED PRICING (MAP) POLICY**.

Password:JDM sales management sets the MAP and reserves the right to update or revise its MAP Policy and pricing structure with no need for prior approval from its dealer and wholesale distribution network. Any revisions or adjustments is solely at the discretion of Password:JDM sales management.

Any dealer and wholesale distributor violating the MAP Policy will have its sales account seized and have any current or pending orders canceled. The following is a review of the Password:JDM MAP Policy:

- 1) The MAP for each product is listed on the price guide under the heading "MAP". All advertisements and reselling of Password:JDM products must be at or above the MAP.
- 2) The MAP applies to all forms of advertising, which includes but is not limited to the following:
 - a. Print newspapers, direct mail and sales flyers, magazines, and product catalogs
 - b. Retail and wholesale company websites, internet-based banners, forums and online auctions
- 3) The MAP applies to all forms of retail and wholesale reselling, which includes but is not limited to the following:
 - a. Retail, wholesale and other storefront and warehouse locations
 - b. Internet-based stores, group-buy internet sites and online auctions
 - c. In any type of "package deal" with other products and services, including shipping and handling, at reduced prices in which the "package deal" equals the actual MAP
- 4) Password:JDM reserves its right to allow the sale of its products as part of a limited-time sales promotion at predetermined promotional sales prices.
 - a. Any sales promotions and pricing, and the length of time for sales promotion, will be determined by Password:JDM sales management
 - b. At the conclusion of any determined sales promotion, all affected pricing must return to the MAP
 - c. Promotional sales prices may be passed along to customers
- 5) Password:JDM will give (30) days notice for any pricing changes to take effect. This includes the following:
 - a. Price increases and decreases to price guide
 - b. End of any promotional sales pricing
